Comment: Overall, Delaware saw an increase of 16% of exiting children since last year's report. In conjunction, we have seen an increase of 20% of referrals to our program. Delaware saw an increase in the number of children who exited due to no longer being eligible for Part C prior to age 3. The Delaware Part C Program discontinued carrying Potential Part B children through summer months during this reporting period. This allowed the program to strengthen its collaboration between Regional Programs and EIS Providers regarding IFSP goals and outcomes. This resulted in more children exiting by meeting their goals prior to age 3. Delaware saw an increase in the number of children who exited who were not Part B eligible and had referrals to other programs. The increase prompted the Program to focus efforts on providing more resources to the families upon their transition. Delaware saw an increase in the number of children who exited the program and Part B eligibility was not determined. Part C continues to refer potentially Part B eligible to the School District to transition. And works with the Part B program to provide the necessary resources to help them determine if the child exiting the program is eligible for Part B. Delaware saw a decrease in the number of children moving out of state as a means of exiting the program. The Program acknowledges that this is a decrease in previous years percentages. It will be interesting to track this trend in future years. Delaware saw an increase in the number of families withdrawing from the program prior to age 3. With the challenges that the State has encountered with provision of timely services, some parents have expressed frustration and are leaving the program to find services outside of the Early Intervention System. Delaware saw a decrease in percentage of families identifying as American Indian/Alaskan Native and Native Hawaiian/Pacific Islander. Upon research, it was found that the families who would normally identify as these two races, are now identifying as b
